

## **CARES Act Higher Education Emergency Relief Fund Statement**

The CARES Act Higher Education Emergency Relief Fund (HEERF) provides funding for institutions to administer Emergency Financial Aid Grants to students for expenses related to the disruption of school operations due to coronavirus.

### **The CARES Act requires all colleges and universities participating in the program to provide the following information.**

- American Barber and Beauty Academy has signed and returned to the Department of Education the CARES Act Certification and Agreement. This document is an assurance that American Barber and Beauty Academy has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.
- The total amount of funds that American Barber and Beauty Academy has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students is \$32,464.00.

  - Enrolled in an eligible program
  - Active enrollment at any time between March 16, 2020 and July 6, 2020.
  - Funds will be divided evenly among eligible students. Grants awarded per student as of December 31, 2020 is \$1,298.56. All allocated student funds have been awarded.
